President Fenlong extended best wishes to Ms. Lynde and congratulated all the new appointments.

VIII. NEW BUSINESS

A. <u>Policy Review – First Reading</u>

(See Sheet #7, Board Minutes File Folder)

President Fenlong introduced a slate of policies the board policy committee recently reviewed for the full board first reading. The second reading and anticipated adoption will take place at the January 9 meeting. **5681 – School Safety Plans – Revised.** Education Law Section 2801-a was amended to require district-wide school safety teams to consider the installation of a panic alarm system as part of their review of the comprehensive district-wide school safety plan. Additionally, 8 NYCRR Section 155.17 was amended to require districts to amend their district-wide school safety plans to include plans for remote instruction beginning with the 2023-2024 school year. *Trustee Roberts commented that any consideration regarding a panic alarm system needs to be included in upcoming capital project discussions. Regarding the remote learning plan, Superintendent Kelly responded to Trustee Roberts that the School Safety Plan is submitted in late summer right before the start of the school year, so there will be time to incorporate a remote learning plan for 2023-24.*

6122 – Sexual Harassment in the Workplace – Revised. An amendment to Executive Law Section 295 established a toll-free confidential hotline for complainants of workplace sexual harassment to provide counsel and assistance to individuals experiencing workplace sexual harassment. The number for the hotline is 1-800-HARASS-3 (1-800-427-2773) and it operates Monday through Friday 9:00 AM to 5:00 PM. Districts must ensure that information on the hotline is included in any materials that they post or provide to employees related to sexual harassment.

6213 – Probation and Tenure – Revised. An introductory paragraph was added to indicate that different probationary and tenure rules may apply for teachers or building principals in certain circumstances stemming from amendments to law which, among other things, exempt districts from having to complete an annual professional performance review (APPR) for any classroom teacher or building principal for the 2020-2021 and 2021-2022 school years. *Trustee Roberts questioned whether the policy was necessary since it mimics Education Law. Superintendent Kelly acknowledged that this revision references Education Law and said she felt it is important to also include it as a district policy. Trustee Roberts also brought up whether Juul Agreements should be included under the Tenure section for consistency, since the policy also references Jarema credit. Superintendent Kelly will review.*

6590 – Determination of Employment Status: Employee or Independent Contractor – Revised. Amendments to 2 NYCRR Section 315.3 require the reporting to NYSLRS of all employees except those who actively participate in another public retirement system.

7150 – Remote Instruction – New. Under amendments to regulations from the Commissioner of Education, districts that would otherwise close due to an emergency may provide remote instruction and count these instructional days towards the minimum requirements. Instruction must be provided to all students and consistent with the definition of remote instruction and a district's emergency remote instruction plan.

7350 - Corporal Punishment/Emergency Interventions - Revised. Revised in light of an amendment to Education Law Section 4402 which requires same-day notification of a parent or person in parental relation of a student with a disability when a physical or mechanical restraint is applied on the student.

7521 – Students with Life-Threatening Health Conditions – Revised. Adds language in reference to using Narcan.

7522 – Concussion Management – Revised. Language was revised throughout the policy to address the updated Guidelines for Concussion Management in Schools (July 2022) from the New York State Education Department and clarifies that a district's medical director has the final authority to clear students to participate in or return to extraclass athletic activities.

7530 – Child Abuse and Maltreatment – Revised. Revised in light of an amendment to Labor Law Section 740 which changed the term "retaliatory personnel action" to "retaliatory action" and amended the definition of the term.

7553 – Hazing of Students – New. The addition of this policy is consistent with our other non-discrimination and anti-harassment policies and emphasizes the connection that exists between and among them.

7619 – Use of Time-Out Rooms – Revised. Revised in light of an amendment to Education Law Section 4402 which requires same-day notification of a parent or person in parental relation of a student with a disability when the student is placed in a time out room.

President David Fenlong reminded everyone they can continue to submit questions and comments that will be discussed at the next meeting.

B. Early Dismissal Drill 12/22/22

Upon presentation and recommendation of Jacquelyn L. Kelly, Superintendent of Schools, motion made by Trustee Laurie M. Roberts, and seconded by Vice-President Todd E. Bates, that the Board of Education approve an early dismissal on December 22, 2022, as one of the eight evacuation drills required by Education Law Section 807:

<u>December 22, 2022 – Early Dismissal Drill</u>. The Gouverneur Central School District, including St. James, will dismiss 15 minutes early on December 22: Gouverneur High School (2:05 PM); Gouverneur Middle School (2:20 PM); Gouverneur Elementary School (3:35 PM buses, 3:20 PM parent pick-up).

YEAS: All Trustees Present NAYS: None.

MOTION CARRIED. EARLY DISMISSAL DRILL, APPROVED AS PRESENTED.

C. Bid Award for Cooler Work at the Gouverneur Elementary School

Upon presentation and recommendation of Jacquelyn L. Kelly, Superintendent of Schools, motion made by Vice-President Todd E. Bates, and seconded by Trustee Laurie M. Roberts, that the Board of Education reject all bids for the Cooler Work at the Gouverneur Elementary School. Bids were opened publicly on December 13, 2022 at 11:00 AM.

<u>DISCUSSION</u>: Responding to Trustee Spicer, Business Manager LaSala stated only one valid bid was received; another was submitted by email so was invalid. Ms. LaSala would like to repost it and make it very clear to all bidders that is must be done right or we can't accept it.

D. Authorization to Declare as Surplus and Sell/Dispose of Equipment
