AMENDMENT TO SUPERINTENDENT'S CONTRACT

Agreement made this day, January 11, 2021, between the Board of Education of the Gouverneur Central School District and Lauren F. French, for the purpose of amending the Superintendent's contract for employment to add the Assistant Superintendent Duties.

WHEREAS, the Board of Education of the Gouverneur Central School District and Superintendent of Schools are parties to an employment contract for the Superintendent; and

WHEREAS, the District's Assistant Superintendent left District's employ and accepted a position in another school district effective December 14, 2020; and

WHEREAS, the Superintendent has notified the District that she will retire effective June 30, 2021; and

WHEREAS, the District requires the performance of the Assistant Superintendent's duties for the remainder of the 2020-2021 school year, but does not at this time know for certain whether the duties associated with the Assistant Superintendent will continue to be performed by an individual in the Assistant Superintendent title, a similar title, or will be redistributed to other administrators after July 1, 2021; and

WHEREAS, the Superintendent has agreed to perform certain duties previously performed the Assistant Superintendent through the effective date of her retirement, for a monthly stipend, with other duties previously performed by the Assistant Superintendent having been reallocated to other administrators; and

WHEREAS, the Superintendent's Employment Contract authorized a 3.5% wage increase for the Superintendent for the 2020-2021 school year, which the Superintendent declined; and

WHEREAS, the Board of Education wishes to authorize a 3.5% wage increase for the Superintendent over her 2019-2020 annual salary for the period December 14, 2020 through June 30, 2021, prorated as necessary, which the Superintendent desires to accept; and

WHEREAS, the parties wish to modify the Superintendent's employment contract to reflect compensation for her performance of Assistant Superintendent duties through June 30, 2021.

Now, therefore, it is

RESOLVED, that the Board of Education hereby authorizes an Amendment to the employment contract for the Superintendent of Schools to reflect that the Superintendent shall perform the duties of the Assistant Superintendent for a stipend of \$1,000.00 per month for the period December 14, 2020 through June 30, 2021, as well as a 3.5% increase over the Superintendent's 2019-2020 annual salary for the period December 14, 2020 through June 30, 2021, prorated as necessary; and

RESOLVED, that the President of the Board of is authorized to execute the Amendment; and it is further

RESOLVED, that this Resolution shall take effect immediately.
