NOVEMBER 3, 2025

I. CALL TO ORDER

The REGULAR MEETING of the Board of Education of the Gouverneur Central School District was called to order by President David Fenlong, at 5:30 PM, in the Middle School Cafeteria, leading those present in the Pledge of Allegiance.

III. COMMENT PERIOD

<u>Halloween Parade</u>. Trustee Tina French commended the Gouverneur Elementary School students and staff after attending the parade and applauded the great job with the venue change from outdoors to inside. <u>Gouverneur Wrestling Club</u>. Jim Minckler, parent and board member of the Wrestling Club, requested consideration to let the school wrestling team members use their Club facility for school practices rather than the Gouverneur Elementary School, where their practices are currently scheduled for the 2025-26 season.

IV. DISCUSSION

A. Presentation: Staff Recognition Award

The District Shared Decision-Making Committee selected Richard Patton, Middle School Band Director, to receive the Award this month. In the words of his colleagues, "Richard has spent the entire summer working on clearing out the auditorium and organizing all things in the light booth and the auxiliary cabinet. He has continued to work hard to ensure that his students are receiving a top-notch band education, and that everything in the auditorium runs smoothly."

B. Wildcat News: Capital Project Update

Director of Facilities Cory Wood provided photos and brief updates of the work at the Dolan building; the well field at the high school, where the 100^{th} well was completed last week; the bus garage; and the stadium project at the Middle School.

C. <u>Public Response to Previous Comments</u>

Superintendent Kelly read a statement addressing the concerns expressed at recent board meetings regarding safety and support in the district, emphasizing that collected school data shows we are making progress in student discipline and classroom behavior. She cited the results comparing the first two months of this school year to the first two months of last school year that showed the number of discipline referrals at the elementary school decreased by 20%, and the number of classroom evacuations decreased by 30%. The middle school saw a significant decrease in discipline referrals of 70%. For the first time, there is a School Resource Officer in every building. The elementary school has a school social worker, two school counselors, two teaching assistant counselors, and a behavior consultant. This is well within the guidelines set forth by the New York State Education Department. The district continues to build on the improvement, including ongoing training of faculty and staff in Therapeutic Crisis Intervention For Schools (TCIS). She concluded, saying, "Accountability and professionalism guide our decisions as a district. And we will continue to maintain high expectations and standards. We will continue to lead with honesty and transparency, and we will continue our mission which is focused on teaching, learning and moving forward together. Thank you."
